Additional Reminders:

- Attendance policy as outlined in the constitution:
 - Council members shall attend every meeting unless an absence is excused by the Chair. Council members who have planned absences shall notify the Chair 24 hours in advance.
 - The secretary will keep a record of unexcused and excused absences, as reported by the Chair, in the minutes.
 - Three unexcused absences may result in removal from the Council.
- To be added to the Constitution:
 - Excused absences examples: sicknesses, class/school activities, religious accommodations, incimate weather, and other instances on a case-by-case basis as discussed with the Chair via email.
 - Being 15 minutes late to meetings, unless previously excused, will result in an unexused absence, on a case-by-case basis. Communicate with the Chair via email or GroupMe.
